2. <u>Discussion re: Proposed ELPS Budget for 2012-2013</u>

Prior to the meeting, Dr. Lombardo presented the Board of Education draft budget for 2012-2013 at the Public Hearing. Dr. Lombardo responded to questions regarding unfunded state mandates, deferment of the full day kindergarten program, unemployment costs to the district, direct instructional categories, and special education related costs. A breakdown of technology purchases, special revenue accounts, and special education student population numbers will be provided. Regionalized and special education contracted services were reviewed. In response to the Board's request, Dr. Lombardo provided possible areas to reduce the budget to 3% and noted the impact the reductions will have on the district. The next special budget meeting is scheduled for Monday, February 6, 2012 at 7:00 p.m.
