

EAST LYME ZONING COMMISSION REGULAR MEETING MINUTES OF May 4th, 2017

1. Request of the Town of East Lyme Zoning Commission for a Text Amendment to amend Section 18, to add Section 18.1.13 Lamp Post Banners Definition and Section 18.1.9.2 regarding Lamp Post Banners.

This item had been continued pending correspondence from the Board of Selectmen.

MOTION (1)

Mr. Donovan moved to withdraw the request of the Town of East Lyme Zoning Commission for a Text Amendment to amend Section 18, to add Section 18.1.13 Lamp Post Banners Definition and Section 18.1.9.2 regarding Lamp Post Banners.

Mr. Peck seconded the motion.

Motion passed, 6-0-0.

 Application of George Mitchell, Manager, Mitchell Trust LLC, for a Coastal Area Management Review of a Mixed Use structure at 239-2 main Street, Niantic, to consist of retail first floor and three apartments on the second floor.

Mr. Mulholland said the site plan has no on site coastal resources and therefore, no chance for adverse impact; the Commission heard testimony at the April 20th, 2017 public hearing.

Mr. Peck asked if we wanted to conditions of all these applications.

The Commission discussed downtown properties.

Mr. Donovan said that everyone's conditions should be the same or the condition should be removed altogether.

Mr. Mulholland said this can be changed for next year's approvals if the commission so wishes.

Mr. Peck said he thinks the annual review gives them enough control and that businesses will be policed anyway. He said no real problems have occurred and he thinks we can loosen up on the rules.

Mr. Donovan said he doesn't understand what is wrong with sitting on a wall. He added if there are problems or fights, that businesses owner can be denied their renewal next summer.

Mr. Dwyer and Mr. Manning both said they agreed and the no alcohol unless you're having food rule is unrealistic.

11. Application of Theodore A. Harris, Agent, for Craig and Tricia Augone, for a five year extension of the approved site plan for the Methodist Street Condominiums project at

41-45 and 45-47 Hope Street, Niantic.

Mr. Harris of 351 Main street came forward and gave a brief presentation.

Mr. explained this project was previously approved in June of 2008; the State rules have changed over the last few years in regards to extension time limits and his client is looking to extend their extension to ensure they have sufficient time for construction. Construction of the condominiums is set to begin in June.
