VII. <u>DISCUSSION/ACTION ITEMS</u>

A. Finance/Facilities/Community

1. Discussion/action re: Proposed FY 12 Budget Transfers in the Amount of \$47,279.00

Dr. Lombardo explained the transfers are necessary to reallocate budget amounts to cover equipment for the TV Studio and Graphic Design class at ELHS, special education assistive devices, and district-wide virtualization server for the network. The budget transfers were reviewed and recommended for approval by the Finance, Facilities and Operations Committee (FFO) on May 15, 2012. Clarification regarding technology purchases was provided as requested.

B. Instruction

1. Discussion/action re: <u>Proposed Recalculation of Grade Point Average (GPA) and Elimination of Class Rank</u> for East Lyme High School Students Beginning with the Class of 2016 or the Class of 2015

Dr. Lombardo's and HS Principal Michael Susi's recommended the modification of the Grade Point Average (GPA) calculation and eliminate class rank at East Lyme High School beginning with the class of 2015 (current freshmen). Discussion has occurred at three (3) Board meetings and Mr. Susi reported on the overwhelming positive parent response.

MOTION: Al Littlefield moved to approve that the district modify the Grade Point Average (GPA) calculation and eliminate class rank at East Lyme High School, beginning with the class of 2015 as follows:

Recalculation of Grade Point Average (GPA)

Weighted Grade Point Average (GPA) will be based on a weighted scale that starts with the simple 4.0 scale for B/C level classes and multiplies grade x weight as follows:

Advanced Placement (AP)/ECE courses are weighted with a 1.15 multiplier;

Honors classes are weighted by a 1.1 multiplier;

A-level classes are weighted by a 1.05 multiplier;

B-level and C-level classes earn a weighted GPA equivalent to the simple GPA and are weighted by a 1.0 multiplier.

Both simple GPA and weighted GPA will be reported.

Simple/unweighted GPA will include all classes including non-leveled electives.

Recognition of Top 20 Scholars

Weighted GPA will be used to determine East Lyme Scholars (top 20) and students from that group would be given an opportunity to "audition" to speak, and all would be recognized, at graduation on the program and with Honor Stoles.

Class Rank

Class rank will not be reported; however, it will be calculated based on weighted GPA and kept confidential for colleges and scholarship applications that require it.

2. Discussion/action re: <u>Proposed Full-Day Kindergarten Study Committee Presentation</u>

On behalf of the Full-Day Kindergarten Study Committee, Assistant Superintendent Brian Reas reviewed the committee's charge, and presented its findings and recommendation regarding full-day Kindergarten programming in East Lyme Public Schools. Based on community feedback, review of research, the district's current Kindergarten experience, and visitations to other districts, the committee recommended the implementation of a full-day Kindergarten program starting in the school year 2013-2014 with an option for one half-day section. Mr. Reas and committee members responded to questions regarding educational benefits, transitioning, optional programs, academic equity, and costs associated with the program. Dr. Lombardo asked the Board to authorize the Superintendent to develop a timeline and fiscal plan to implement a full-day Kindergarten program starting in the school year 2013-2014 with an option for one half-day section. Dr Lombardo will update the Board early next fall. The Board thanked the committee for their work.
