- 1. Review ELPS Alignment Progress re: Common Core State Standards (CCSS), grew out of
  - Students not prepared for post HS (nationally)
  - Achievement Gap (nationally)
  - Students can't meet the rigors of college or job market (nationally)
    - Rigor defines as increased complexity of thought not level of content
    - State of CT adopted Common Core in place of state framework
    - Pam Nowak and Lynn Hansen meeting to adjust current course curriculum with CCSS.
    - Also, found the focus to be on process writing most at the elementary level, need to be well versed in all types of writing (narrative, expository and persuasive) @ grade 3
    - Gap analyses being conducted K-12 in math and language arts.
    - May 11 received first draft of Science Standards, science will be interdisciplinary. >> shifts of how science courses will rollout
    - In district language arts will be addressed thematically with a balance of genre.
    - 2 RFP –SBAC (Smarter Balanced Academic Consortium) and PARCC (Partner for Assessment for Readiness in College and Careers)
    - SBAC has awarded CTB-McGraw Hill to write test items and Pearson to develop Technology Readiness Surveys.
    - CT is a member of SBAC and a governing state.
    - CMT/CAP replaced by SBAC.
    - Nice Caveat is portable student scores among states that are part of SBAC.
    - Additional PD will be needed for teachers to rise to the challenges of rolling out showcases, rollout to schools
    - Kansas has a lot of samples and ideas related to CCSS.
    - Portfolio K-4 in East Lyme with the CCSS crosswalks have been updated at all three elementary schools. School PLCs s work in grade level teams and have frequent opportunity to review
    - States may decide to utilize SBAC components differently (Summative, interim and formative assessments and resources). Different options available to states through the "bundling" concept.
