#### VII. <u>DISCUSSION/ACTION ITEMS</u>

A. Finance/Facilities/Community

Melissa Ford seconded.

1. <u>Discussion/action re: Proposed 2009-2010 Federal Special Education Grant Programs</u>
Dr. Paul Smotas presented the applications for 2009-2010 federal special education grants. Grants included the district special education grant and the preschool grant which totaled \$492,595 and \$12,251 respectively. Additional funds are expected from the stimulus plan.

# 2. Discussion re: 2008-2009 Budget Update

The Budget Subcommittee met prior to the Board meeting. Committee Chair Tim Hagen provided an update of the FY 09 budget status with an estimated balance of \$195,000. It was noted that a savings of \$300,000 was realized as a result of unfilled positions, long-term substitutes and breakage fees from 29 new teachers being hired at the start of the school year. Currently, there is a projected deficit of -\$13,031 in Special Education. Concern continues that the State of CT will reduce our excess cost reimbursement from 90% to 75% given the State deficit. If that occurs, an additional deficit of -\$135,000 is projected.

#### 3. Discussion re: 2009-2010 Budget

The 2009-2010 Town Budget was adopted by an overwhelming margin. Adstaff met today to discuss staff adjustments and Dr. Smotas will consult with bargaining units this week before finalizing staffing. A concentrated effort is being made by the administration to provide speedy notification to all affected staff. As a result of the Futures Health Core evaluation, two school buses will be eliminated which will result in savings of \$70,000. The Board will review and finalize the 2009/2010 Budget on June 8.

4. <u>Discussion/action re: Proposed Donation of Crew Equipment/Assets from the East Lyme Rowing</u>
Association to the East Lyme Public Schools

Due to an administrative oversight, the equipment/assets purchased through the East Lyme Rowing Association fundraisers were not previously approved as donations to the Board of Education.

- 3. <u>Discussion/action re: Proposed 2009-2010 East Lyme Middle School Student/Parent Handbook</u> ELMS Principal Judy DeLeeuw outlined proposed minor changes to next year's handbook and the addition of sections on Scientific Based Interventions (SRBI) and Positive Behavior Support (PBS).

1. <u>Discussion/action re: Proposed Early Retirement Incentive Plan for ELPS Secretaries</u>
The 2009-2010 Budget reflects a reduction of four (4) secretarial/library staff. As an attempt to avoid an involuntary reduction in force, the Board of Education proposed an early retirement incentive plan to members of the secretarial bargaining unit and the Central Office confidential secretarial staff. Under this plan, secretaries would have the option of two (2) years of free, self-only medical insurance or a cash payout of \$5,000 per year for two (2) years. Two (2) members of the secretarial bargaining unit applied for inclusion in the plan with a 2009-2010 approximate savings of \$77,000. A middle school secretary, Rowena James, retired in January 2009 and will not be replaced.
