3a. Continued Discussion – Samuel Smith House

Mr. Formica noted that Ms. Hardy was travelling with her students and Mr. Seery was out of state. He added that we are still awaiting appraisals and have started negotiating with the owners. He added that this item will be continued on the next Selectmen's agenda.

5a. Ex-Officio

Mr. Wilson had no report.

Ms. Cheeseman had no report.

Mr. Nickerson went to the Economic Development Commission meeting. Chair Steve Santino stepped down and was presented with a plaque by the membership. He added that he was a great leader and wished him well. He said that Ms. Bengston attended her first meeting and that they will be rotating the office of Chair for the next few meetings. He said that they discussed the Visitors Center and the Plan of Development economic development chapter.

5b. First Selectman's Report

Mr. Formica said that the regional water connection continues to move forward. He said that he served as a "mystery reader" at LB. Haynes School.

Plans for Opsail continue to move forward for 7/7 and 7/8 and that the opening ceremony will be at McCook's on 7/6 with approximately 10-15 ships in the harbor. He said that we hope to have a street festival that day, but there will be no street closure.

He attended two Council of Government meetings and met with CT DEEP regarding traffic concerns at Rocky Neck State Park.

He attended a 90's Tea at the Commission on Aging.

He noted a program slated for August where 2-38 year olds will be invited to participate for a round table discussion on how to keep this age group here in Niantic and in SE CT.

Mr. Formica noted that the Annual Town Meeting was held on May 14th and the 5 Year Capital Plan was approved and that the budget was sent to a referendum vote on May 24, 29, 2012 from 6:00 a.m. – 8:00 p.m.

6. Public Discussion

Mark Christensen of Grassy Hill Road and Co-Chair of Conservation of Natural Resources Commission requested that the First Selectman write a letter to CT Department of Agriculture noting that the Town of East Lyme satisfies the prequalifications for the Community Farms Preservation Grant. He added that the letter had to be received by May 31st.
