Approval of Minutes:

Report of Robert Albright:

Bob Albright reported he spoke with Allison Woods regarding fund raising of proposed renovations to the pool facility. The motion and financial statement will be e-mailed to Committee members with a return e-mail vote. All votes are yes to paying the incentive.
