TOWN OF EAST LYME SMITH-HARRIS HOUSE COMMISSION REGULAR MEETING MINUTES

Wednesday, January 22,2014

I. Call to Order

Chairman Lakowsky called the January 22, 2014 Regular Meeting of the Smith-Harris House Commission to order at 7:07 PM.

II. Approval of Minutes

No action was taken, because it was an informal discussion.

III. Reports

- **A. Public Delegations.** There were no quests.
- **B. Ex-Officio Report.** Mr. Wilson was unable to be present, and there was no report.
- C. Curator's Report. See attached Report.
- D. Agenda Additions.

MOTION (1): Ms. Prokop moved to add under New Business, B. 3. Bylaws Change and B. 4. Election of Officers. Seconded by Mr. MacDonald. (4-0) Unanimous

E. Chairman's Report.

1. New Members. Ariel and Darlene DeLaura were welcomed as new members of the Smith-Harris House Commission.

Mr. Lakowsky reported Ms. Medley is working diligently on the June Eighth Grade Program.

F. Financial Report

1. Status Update. Mr. MacDonald reported as of January 21 we have expended \$5,177.29 and we have an unexpended balance of \$8,862.71; \$2,920.79 is encumbered.

Mr. Lakowsky reported he attended Board of Selectmen and Board of Finance meetings to request \$2,500 for the Curator for the remainder of the year. A Town Meeting will be held to request approval of this amount.

2. Presentation of Bills. Mr. Lakowsky presented bills for invitations, envelopes, cards, and paper for a total amount of \$69.07.

MOTION (2): Ms. Prokop moved to reimburse Mr. Lakowsky \$69.07 for supplies for a program in the barn.

Seconded by Darlene DeLaura. (4-0) Unanimous

- 3. Barn Rentals. Ms. Prokop reported the barn is rented on October 11, 2014.
- **G. Collections Committee.** There were no new donations.
- **H. Correspondence.** There was no new correspondence.

IV. OLD Business

A. Property Maintenance

- 1. Garden Fence and Maintenance. The fence will be taken care of at springtime.
- **2. Driveway.** Mr. Lakowsky spoke to Chuck Holyfield, and Mr. Holyfield agreed to have the driveway taken care of in the spring.
- **2. Tree Limbs.** Mr. Lakowsky has asked Mr. Putnam to take care of the tree limbs. Mr. Putnam agreed to have them taken care of at springtime.

V. NEW Business

Ms. Prokop informed the Commission that the Garde will have a program on the Civil War on January 23.

Mr. Lakowsky met with Messrs. Peck, Jr. and Schutt and discussed in June using the senior bus to transport people from one historical house to another. Each house will have a different program.

Ms. DiMartino signed up for a NEMA seminar to be held January 29 on "Marketing a Museum on the Shoestring Budget".

MOTION (10): Ms. Prokop moved to nominate Richard MacDonald as Financial Officer of the Smith-Harris House Commission for 2014. Seconded by Mr. Lakowsky. (4-0) Unanimous.

MOTION (11): Mr. Lakowsky moved to close nominations for Financial Officer of the Smith-Harris House Commission for 2014. Seconded by Ms. Prokop. (4-0) Unanimous.

A vote was taken, and Mr. MacDonald was unanimously elected Financial Officer of the Smith-Harris House for 2014.
