  - f. Patrons shall not use the patio area for consumption of alcohol unless seated at a table.

- 2. Service will be from 11:00 a.m. to 11:00 p.m., the last seating will be allowed at 10:00 p.m. All service shall cease at 11:00 p.m.
- 3. Upon request of the East Lyme Cemetery Association, any entertainment outside will be halted for burial services;
- 4. There are to be 9 fixed seats around the service counter and 5 fixed seats around the tabletop and that will be serviced by wait staff.

street the restaurant will be torn down soon. He thinks the Main Street building will be starting in the Fall. 38 Hope Street was in for their permit on the center building.

## 4. Comments from Ex-Officio

Ms. Cheeseman stated the Board of Selectmen met last week. They signed the Call for the Town Meeting. Ms. Hardy talked about putting together a business listing, and she is working with the Assessor's office on that. The Referendum to vote on the budget is next Thursday from 8:00 a.m. to 8:00 p.m. They are still waiting on Amtrak for the Boardwalk.

Chairman Salerno asked when the water connection line will be completed.

Ms. Cheeseman will find out for their next meeting.

# 5. Comments from Zoning Board Liaison to Planning Commission

Mr. McPherson went to the April 1<sup>st</sup> meeting, and they discussed a subdivision based on the Conservation by Design Regulations, which never got Town Attorney approval.

Mr. Mulholland stated the Town Attorney doesn't need to approve it. This application is the first one under the Regulation. When you write a complex Regulation you try to analyze it best you can. Some questions have arisen. They have decided to ask him because the question has to do with the Zoning Regulations. He is attempting to assist Planning.

### 6. Comments from Chairman

Chairman Salerno stated the Zoning Regulations Review subcommittee will be tentatively scheduled for the Thursday between the two meetings in June.

Mr. Walker asked for a replacement for the May 20<sup>th</sup> Planning meeting. Mr. Kane will check his availability.
