## Public Delegations

On October 24, 2015 from 3-6 PM would be Spirit voices - Victorian Mourning and Spiritualism with Tours of the Burial Ground costing \$10 per person or \$30 per family. #### Cynthia DeHaan Gift

Mr. Lakowsky said that Ms. Sasso had come up with the idea of planting a boxwood tree in Ms. DeHaan's honor on the grounds – the question is where they would like to plant it. A suggestion was made to plant it near the door as there is a spot there for it.

Ms. Prokop will check into where to purchase the boxwood, when to plant it and the approximate cost and let them know at the next meeting.

It was also noted that the Care & Share donation in December will be made in memory of Cynthia DeHaan.

Mr. Lakowsky lastly noted that he has a 2008 map detailing the land for the Historic Register and that the area marked in red has what was presented at that time in relation to the overall area for the Smith Harris House. He said that he is proposing that the back area of some  $400' \times 400'$  and an area at the entrance also be part of their property as it is more in line with what they do. He said that he would like their approval to present this to the Board of Selectmen.

# 19th Century Funeral Customs

"Many people did not fear death; rather, they feared not being "properly" mourned" (National Park Service, 2011)

# Preparation before the funeral

- It was customary for the clock in the room of the deceased to be stopped at the time of passing and would not be restarted till after the passing.
- All blinds and curtains were closed
- A black wreath was hung on the doors in order to let others know that someone had passed (at this time mourning was public and shared with in the community)
- Mirrors and any reflective surface was covered in black cloth
- Crepe, a black cheese cloth like material, was draped on mantels, shelves, and window sills. (White draping would be used if it was a child that had passed)
- Many times herbs such as rosemary were laid out around the parlor to help mask the smell
- Families would send out funeral cards or invitations to let family and close friends know of the passing and the day it would be held. These were typically white with black bordering
- Postmortem postcards were sent to family members who were too far away to attend the funeral.

# **Body Preparation**

After death the body was laid out and washed. Men would wash the deceased if they were male and women would wash them if they were female. The body was then wrapped in a shroud that had long sleeves and an open back. It would not be till later on that people would begin to bury people in their own clothing. Next the body was placed in a coffin in the parlor usually atop saw horses or two ladder back chairs. After the minister prayed over the body the coffin was nailed shut and draped in a black shroud to be taken to the cemetery.

# Keepsakes

- Memorial cards were handed out at the funerals and were considered tokens of the dead. These had the deceased's name, birth date, death date, number of years months and days of life, as well as an uplifting poem or message.
  - Mourning portraits were pictures, sketches, or paintings of a family member dressed in mourning usually holding a portrait of the dead.
  - People would make items that could be used to remember the deceased. Examples are samplers, hair wreaths, monuments, etc.

# Women in Mourning


- Colors that were worn defined the degrees of mourning and the distance of relationship to the dead
- Women's mourning could last up to two years or longer
- There were 3 stages to a women's mourning
  - O Deep Mourning- this was for a spouse or child and could last up to a year
    - Women only spoke to close family members and secluded herself
    - Could only wear black
    - Usually had a bonnet with a black veil to wear outside
    - Black gloves, handkerchiefs, handbags, fans, and mourning jewelry
  - o Second Mourning-lasted 9-12 months
    - Full mourning cuffs and collars were replaced by white cuffs and collars
    - Veils could come off
  - Half mourning
    - Lasted 3-6 months
    - Could were purples, mauves, and grays

# Men in Mourning

- Men wore their best dark suit and usually a black band around their arm or hat
- Men were expected to be the strong ones and return to work as soon as the dead were buried
- Men could remarry shortly after their wife's death in order to find a mother for his children
- Depending on how long ago the wife had died the new wife might have to take up mourning for the deceased

# **Changing Times**

- By the 1880's hospitals had become an acceptable place to die
- Funeral director had become a profession and funerals were occurring in funeral parlors
- Grief became less public
- Coffins changed shape and became caskets by the late 19th century
- People were no longer being buried as much on personal property
- The first rural cemetery was established in Boston, Mount Auburn Cemetery

# **GRANTS**

The big news is that much of my early- to mid- September hours were spent in applying for three (yes, 3!) grants to cover beginning initiatives in our collections management, to allow us to both generate a significant basis for our inventory, but also allow us to extend our knowledge to our visitors. The grants proposals were sent to:

- Niantic Rotary Foundation, for \$1000 toward the purchase Past Perfect software (\$1004.00, with our AASLH member discount);
- Foundation of the American Institute for Conservation of Historic and Artistic Works (FAIC) for materials and supplies to offer an "Angels Project," under the supervision of textiles expert Susan J. Jerome, to document, clean, and properly store our complete textiles collection with a committed group of volunteers;
- Chelsea Groton Bank for \$1050.00 to cover the \$150.00 honorariums for a local conservationists to lead a series of seven "Preserve Your Past" workshops from April through October 2016 for the general public on how to best care for their own family heirlooms and antiques.

This last is an initiative to celebrate the 40th Anniversary of the Smith-Harris House. As the community of East Lyme banded together to save and preserve the House, in turn the museum will share its knowledge by offering a series of workshops to assist residents in saving and preserving their own personal heirlooms and collections.

The current STEPS-CT Sub-Committee: Donna Massung, Kathleen Patterson, Kathleen Sasso, Maggi Prokop, and director Joanie DiMartino met throughout the month to continue with STEPS-CT work.

- We begin the Management (MGMT) section next week, which will feature budget-related policies and documentation.

- We will need to pay for our Constant Contact account, as well. (\$378.00; yearly pre-paid discount of \$162.00)
- I will be creating a new Facebook page for the Smith-Harris House; stay tuned!
- We will be participating in a "Mystic Country"-wide initiative managed by the Southeastern CT Cultural Coalition to generate a "Historic House Trail" brochure which will be placed all over the state to promote the many different historic houses in this area.

# Programs/Education

The Bi-centennial Quilt has been found.

The Time-Life Civil War books are awaiting a decision from the High School Library.

I have switched my attic focus to ensuring that all textiles currently in the attic are conveniently arranged near the stairs for the Regional Angels Grant program scheduled in March.

As we approach the Holidays the decorations scattered in the attic will also be brought forward away from in front of the attic window for easy access.

The attic window is in need of repair so it is important to clear away the clutter there. Please see attached for a description of the window.

Tuesday September 22 I attended a program about Outhouses at the Library. It was very informative and the presenter Mr. George Papp, Sr. is very anxious to visit our Outhouse. He mentioned archeological digs at Outhouses have turned up very interesting finds. I asked him his opinion concerning the painting of historic Outhouses and he felt they were usually white washed or natural wood. There would not be any attempt to draw attention to an Outhouse. He did start out by saying Lilacs or other bushes were often planted around the Outhouse to obscure them from view. He donated a monogrammed roll of paper to the museum; it will be placed in the "Special Use" department.

The term "Chinese Chippendale" used to describe the Smith-Harris 36 pane window was first mentioned by the architect Robert I. Carter hired by the Restoration Committee. Bob specialized in the 18th century.

The infill between the top and bottom rails and the vertical supports is a series of interlocking diagonals, although rectilinear "The term Chinese Chippendale in architecture is applied to a specific kind of railing or balustrade that was inspired by the 'Chinese Chippendale' designs of designs exist as well."

(definition provided by Wikipedia; reference to This Old "The design was popular in the United States in the late 18th and early 19th centuries. Prominent examples of the style exist on the wing terraces and House article) Chinese Chippendale does not refer to something built by Thomas Chippendale (1718-1779) but rather the term refers to a design developed by Thomas Chippendale and very often copied by others.

In 1754 Thomas Chippendale became the first cabinet-maker to publish a book of his designs titled The Gentleman and Cabinet Maker's Director. Since the Chinese appeared in his book. It is not a stretch to imagine that craftsmen would adopt his Chippendale design carries his name it is likely that some of those designs designs for their own purposes.

we can tell from the fine woodwork that the builder was an experienced craftsman, Although we have little knowledge of the specific builder of the Avery homestead and most likely had access to books on his trade.
