At the end of the ride there will be food and a free tee shirt for participants. We are planning on the shorter distance riders to visit the three historical houses in Town. Mr. Nickerson has volunteered his band to play at Rocky Neck. Parks and Recreation has agreed to loan seed money for the Bike Ride. The next meeting will be held on March 15 at 6 p.m. in the Parks and Recreation meeting room.

At the urging of the Agribusiness Subcommittee, the Zoning Commission agreed to signage concerning farm tractors on public roads. Also they plan to meet with Zoning on the need for honey bee regulations.

C. RBA--Ms. Heller.

Ms. Heller reported the water levels are low and they cannot get RBA readings.

Mr. Danila invited Commission members to attend a Workshop on March 25 at Yale on insect identification.
