- 1) The meeting was called to order at 7:31 pm after a quorum established.
- 2) The minutes of the May meeting were reviewed and accepted on a motion by P. Spakowski, seconded by E. Kanter; all in favor; motion passed.
- 3) Treasurer's report was reviewed including the financials on a motion by P. Spakowski, seconded by L. Tytla; all in favor; motion passed.
- 4) Chief Warden's Report-
 - The shellfish areas are currently open.
 - The new DA/BA contact replacing D. Lamoureaux is Environmental Analyst, Alissa Dragan.
 - A notification of open/closed shell fishing areas occurred with DA/BA recently.
 - A mooring located outside Keeney Cove has a 20 ft. vessel; R. Miller will investigate.
 - A trailer replacement was discussed. F. Grimsey offered the use of his trailer in the interim.
 - Boat is running well.
- 5) Subcommittee Reports -
 - The DEEP gave permission for the Camp Niantic Exclusion Zone buoys installation.
- 6) Old Business
 - a) Members reviewed the By-laws. A motion made by R. Miller, seconded by P. Spakowski to accept the By-laws as currently written with no changes; all in favor; motion passed.
 - b) T. Londregan, Owner of Niantic Bay Shellfish Farm reviewed a revised proposal for creating a sustainable shellfishery including a map of preferred sites and growth methods.
 - c) Permit re-design was tabled.
- 7) New Business
 - a) Mooring placement in the Niantic River was discussed as it relates to aquaculture, water skiing, jet skiing and tubing.
 - b) The Private Aids to Navigation (PATON) were recently checked and some violations were found by the DEEP.
 - c) Deb Surabian is conducting the Soil Survey; it will continue throughout the summer.
