**1. Call Meeting to Order**

Mr. Walker called the East Lyme Aquifer Protection Meeting of November 2, 2017 to order at 7:01 p.m.

**2. New Business**

- a. Approval of Registrations & Issuance of Certificates**
  - i. 208 Flanders Road; DeBartolo's Auto Repair**

Mr. Mulholland noted there is an email in the Member Packet from DEEP endorsing the application albeit with one condition; in Section 4 of their application employees should sign off for their training with the Materials Management Plan.

**iii. 36 Industrial Park Road; New England Pump and Valve Co.**

Mr. Mulholland noted this company repairs and overhauls all types of industrial pumps such as centrifuge, diaphragm, multiple impeller, vertical turbine and so forth. They rebuild and repair all associated systems such as control systems, speed reducers and gear drives.

DEEP had no comment on this application. Mr. Mulholland clarified that this is a different type of activity from DeBartolo; the dealings with solvents are minimal, less intense, and more of manufacturer activity.

**Mr. Peck moved to approve and sign the registration of New England Pump and Valve Co., for the underground storage or transmission of oil or petroleum.**

**iv. 218/226 Flanders Road; Crest Ford**

Mr. Mulholland explained this is a new/used automobile dealership that performs automobile repair/maintenance of vehicles with internal combustion engines.
