A. Continuation of Water Study. Mr. Carlson read draft of letter to the East Lyme Board of Selectmen suggesting a catch basin system along I-95. The Commission will forward a finished copy by Thursday April 13, 2017, to the Board of Selectmen.

Mr. Christiensen stated the revision of exit 74 will go through the aquifer protection zone. He asked Mr. Mulholland to consider a spill mitigation system along the highway.

There will be a presentation on the restructuring of I-95 on April 18 at 6 p.m. at Camp Niantic.

- A. Communications. There were no communications received.
- **B.** Agribusiness Subcommittee. Mr. Christensen reported a Beekeeping Meeting was held on March 17. There was discussion on sustaining our bees and other pollinators. Mr. Dinsmore received information on Beekeeping Regulations from the Town of Wallingford. He plans to meet with Mr. Mulholland.

Open Farm Day will be held on July 16. The Samuel Smith House and Old Orchards farms will be open to the public. The Connecticut Farm Bureau would like to contribute and will bring a donkey to the Samuel Smith House.

Music at the Old Orchards farm has been denied. A rework is in progress.

The Agribusiness Subcommittee plans to have a float in the Memorial Day Parade and will participate on East Lyme Day on Methodist Street.

Mr. Nichols reported that the Save the River Save the Hills group will have a Science Walk on the Boardwalk.

On April 29 there will be a Walk for Climate Change legislation in Washington, D.C.
