5. New Business

a. Move to approve a Police Mutual Aid Agreement. MOTION (2)

DISCUSSION: Chief Finkelstein stated that this agreement has been in place for a long time, and allows us to share resources with surrounding towns for special events. This is an updated agreement from the last one signed, and the Chief has reviewed both and is comfortable with the updates. Motion by Mr. Nickerson. Seconded by Mr. Powers. Motion passed 6-0.

b. Move to approve a Community Enhancement Task Force Agreement. MOTION (3)

DISCUSSION: Chief Finkelstein stated that this is a regional task force which allows sharing of information, assets and is comprised of people with specialized talents and specifically deals with drug enforcement in the region.

Motion by Mr. Gardner. Seconded by Mr. Perkins. Motion passed 6-0.

c. Discussion and possible action regarding parking issues on Shore Road.

DISCUSSION: Chief Finkelstein reported that there has been a lot of conflict over the no parking signs being put up on Shore Road. He asked that we discuss this matter at a future meeting to give him more time to review the situation.

DISCUSSION: Mr. Price opened up discussion regarding this act and noted that this act now includes guidelines for data storage as it relates to FOIA. Chief Finkelstein advocates the use of body cameras by our police officers. It was decided that this matter would be reviewed further and discussed at a future meeting.
- c. Mr. Price stated that there has been discussion about the Police Department pickup truck. This vehicle is not designed for patrol, and there are a number of options of what to do with it going forward; i.e., using it for road work assignments or swapping vehicles with either Public Works or with the Fire Marshal. This matter will be open for discussion at a future meeting.

DISCUSSION: Mr. Price stated that the By Laws of the East Lyme Police Department need to be amended to change the monthly Commission meeting day to the second Thursday of each month. That change was discussed and approved at a recent Police Commission meeting, but a vote was not take to actually approve the modification of the By Laws. The By Laws will be updated by the Secretary and submitted to the Town Clerk.

Move to approve the by-laws, as amended Motion by Mr. Gardner. Seconded by Mr. Perkins. Motion passed 6-0.

Section 1: Noteworthy Incidents

On July 1, 2017 at 0000 hrs the East Lyme Police Department made the successful transition from the Resident State Trooper program to an independent Police Department.

Fourth of July -

This year's Fourth of July Holiday arrived with beautiful weather and large amounts of visitors to the Niantic section of Town. In all, we had 18 Officers scheduled to work portions of the day. This included Patrol, Beach, Traffic, neighborhood, and Marine Patrol(s). In all, the Department handled 94 Calls for service that Day/Eve. This includes a drug overdose with narcan save and water rescue just outside of East Lyme waters.

During the Fourth of July weekend members of the East Lyme Fire Marshal's Office, the State Fire & Explosion Investigation Unit and the East Lyme Police Department seized approximately 200 pieces of fireworks from multiple locations.

Celebrate East Lyme Day -

This year's celebrate East Lyme day was a very successful event. Tens of thousands of people came to Niantic for your celebration and fireworks. This year we incorporated increased security to guard against vehicle access to Main St. We also utilized significant mutual aid assets to help make the event successful and secure. This included 12 mutual aid Officers from Law Enforcement Council Departments (Waterford, Montville, New London, Norwich, Groton City, Ledyard, Stonington, and Amtrak). We also received assistance from 2 New Haven Police Officers and their Mobile Communications Vehicle. This, combined with our regions vehicle, provided an enhanced level of monitoring during the event. We also established a forward command post at the East Lyme Police Department to run direct dispatch and logistical functions, while also providing a walk in area for citizens. In all, the large scale event resulted in two criminal incidents (Assaults) with one arrest.
