a. Priority List Update

Mr. Nickerson thanked all the members of the Police Commission and congratulated them on their hard work and dedication during the process of moving to an independent police department. This Commission worked tirelessly to interview and hire a Police Chief, and to prepare the police department and the officers for the transition to an independent police force, and their efforts are to be commended.

c. Review and possible changes to the approved meeting schedule DISCUSSION: Mr. Price stated that since we are on the eve of the police department going independent, the Police Commission no longer needs to meet twice a month.
