I. CALL TO ORDER. Chairman Seifel called the Smith-Harris House Commission May 24, 2017 Meeting to order at 7:00 p.m.

II. APPROVAL OF MINUTES. Mr. Seifel asked for additions, deletions or corrections to the April 26, 2017 Smith-Harris House Commission Meeting Minutes.

MOTION (1):

Mr. Lakowsky moved to approve the April 26, 2017 Smith-Harris House Minutes, as presented. Seconded by Ms. Prokop. (4-0) Unanimous.

III. REPORTS.

A. Public Delegations. Ms. Massung reported the Friends/Commission Planning Meeting will be held on June 2 at 4 p.m. in the barn.

The Friends' Annual Meeting will be held on June 10 at 9 a.m. in the barn.

Ms. Patterson gave the attached report from Mr. Patterson.

Ms. Massung received an email from Eli Doggart. After he receives approval, he will get back to us.

Ms. Patterson and Ms. Massung have identified and listed 129 items in the house collections.

Mr. Bumgarner works for the East Lyme Sewer Department. Ms. Rossi is a dispatcher and Sergeant Hallbauer has worked for the Town for nineteen years. They would like to have a

Halloween Festival on the Smith-Harris House property. Non perishable food items will go to Care and Share and pet supplies will go to Waterford/East Lyme Animal Control. Any cash donations will be donated to the Friends of the Smith-Harris House. Ms. Rossi stated we have had this event for five years at other locations. It is a family event. Last year there were 300 in attendance. We control the size of the group. Mr. Cunningham asked how large is the group? Ms. Rossi informed him the largest group we have had is ten.

Sergeant Hallbauer would like the Police Cadets to become involved. He reported they will use LED lights. We will have guides. Portapotties will be needed.

This event will be held on October 27 and 28 from 6 p.m. to 9 p.m.

Ms. DiMartino asked will you go out to the woods? Sergeant Hallbauer replied it will take place at the perimeter of the barn and the house grounds.

Ms. Rossi added we will bring in our own generator.

B. Ex-officio Report. Mr. Cunningham reported the Board of Selectmen received a suggestion to put banners on the Main Street lights. This matter was tabled for more thought. It was felt it might be dangerous to have another distraction on Main Street.

The Board of Selectmen approved a lease agreement with the Lions to allow them to hold the Lobsterfest.

The Band Shell on the upper parking area has been completed. All of the sound will be projected over the water and will not disturb the neighbors. Music and/or arts will be held on Friday nights throughout the summer.

C. Director's Report. See attached report.

Ms. DiMartino suggested using sign-up.com for dates Commission or Friends members are available to give tours. Volunteers will receive a reminder through this website.

D. Agenda Additions. The Commission was asked if they had any additions to the Agenda.

Ms. Meiers moved to reimburse Ms. Prokop an amount not to exceed \$60 to attend the CT League of History Organization's Annual Conference on June 5, 2017. Seconded by Mr. Lakowsky. (4-0)

- 3. Barn Rental. Ms. Prokop reported she was in contact with individuals who wanted to rent the barn, but chose not to because of the Town's alcohol policy of no alcohol on Town property.
 - 4. Budget Planning Committee.

a. Review Budget and Planned Expenses. The Smith-Harris House 2017-2018 budget was approved.

5. Director's Compensation. Mr. Lakowsky reported compensation for Ms. DiMartino was increased to \$6,000.

MOTION (4):

Mr. Lakowsky moved to increase the Director's rate of pay to \$15 per hour, effective July 1, 2017. Seconded by Ms. Prokop. (4-0) Unanimous.

6. NEMI Workshop.

MOTION (5):

Mr. Lakowsky moved to approve the expenditure of \$65 to allow Ms. DiMartino and up to five Commission or Friends members to attend the NEMA workshop on June 6 from 1-5 p.m. Seconded by Ms. Meiers. (4-0) Unanimous.

G. Collections Committee.

Ms. Patterson reported we have received a gilded mirror which we have several of. We received a lyre base table. We have a similar one. We received four balloon chairs which are from an earlier period. We recommend that we decline these donations, because they are similar to what we already have.

We received from Monica Detlann two tables, a red glass painted lamp, and pewter candle sticks. One table is similar to the one we have. We are interested in one table and possibly the lamp and pewter candle sticks.

To date Ms. Patterson has not seen the baptismal gown but would like to see it.

She stated an appointment will be made to see the 1930 Niantic postcard, dolls and textiles.

- 1. Garden Fence and Maintenance. The garden fence and maintenance of it will be done by an Eagle Scout as soon as he obtains approval.

- 3. Clean Up Day. Mr. Lakowsky reported we had an excellent Clean Up Day. We had 15 students from the High School, our regular crew and the Lions. Butch Foster removed stumps with his backhoe. Eli Doggart removed stones from the garden and did some weeding.

- 1. Bike and BBQ 2017. The Bike and BBQ 2017 is scheduled for October 1. They anticipate 400 visitors to the house on that day. They are looking for major sponsors and are getting help from an outside fundraiser. The Lions will prepare the food. Each historical house will have a booth or table. There will be a stop at the Lee House and Samuel Smith House.
 - 2. Middle School Program. (See Director's Report).
- 3. Walk of Horror. Mr. Lakowsky felt the individuals running the Walk of Horror are knowledgeable of the Town.

Ms. DiMartino stated her only concern is it will over shadow Spirit Voices on October 21. Ms. Massung felt each would serve a different group of people. Ms. DiMartino asked if the Commission wished to have the first floor opened? They did not. It was felt Walk of Horror will be a great fundraiser.

STEPS-CT Grant

- WE GOT THE GRANT!!!
- We need to set up a few potential dates in June for our preliminary site visit with our consultant.
- We should take advantage of the NEMA workshop, "Plan the Work, Work the Plan: Strategic Success for Museum Leaders" on creating effective strategic planning. This will take place at the Hill-Stead Museum in Farmington, on 6/6, from 1 pm to 5 pm. We must send director, and up to 5 board members; if would be ideal if both Commission and Friends are represented. Cost is \$65 total.

STEPS-CT

- STEPS-CT sub-committee is still meeting; we are in the process of developing new board manuals—coming soon!
- Key Policy—this was confirmed by the Commission last year; we need to put this policy in place.
- We received from the Town a large First Aid box; we need to determine location. Through our disaster plan work, we have a list of items that it must contain; we just need to purchase them.
