Mr. Mulholland stated items 1 and 2 from the Planning Commission have been addressed,

The language "lightweight and durable fabric" was added to Item 7.

Mr. Mulholland stated they will need to get approval from the Board of Selectmen.

The language "business and/or political advertising" was added to Item 6.

Mr. Donovan stated he brought this item up. There could be beautification grants out there for this.

Mr. Dwyer asked about time limits.

Mr. Donovan stated that would be up to the Board of Selectmen.

Mr. Mulholland stated the Board of Selectmen is the Town's administrative body, they control the lamp posts.

Number 8 was added to read "Such banners shall be limited to town use".

There was additional language added to Item 7. The whole item should read "Banners shall be made of a lightweight and durable fabric and similar flexible material, and shall not be illuminated.
