# 3. Public Delegations

### A. Delegations from the Public

Ellen Fratus suggested the Commission have a Public Comment section at the end of the agenda so the public can comment on the discussions of the Commission. She commented she and others were still concerned about the location of the proposed shellfish farm.

Chairman Dinsmore stated that the East Lyme HM/S Commission is only responsible for shellfish farming in the Bay outside the Niantic River. Mike Leventry, 11 Oswegachie Hills Rd,. stated there was a WELSCO meeting scheduled for Thursday concerning area 2 and 5 for aquaculture.

#### A. Shellfish

Kantor reported the shellfish areas are now open but had been closed due to a heavy rain event. He spoke to a few shell fishermen and they stated there are plenty of clams and oysters.

Kantor attended the annual State shellfish meeting. He stated it was very productive with a lot of good information provided on aquaculture.

## B. Harbor Master - no report

The members asked the Chairman to remind the Harbor Master to provide the moorings spreadsheet.

#### C. Treasurer

D. Landers informed the members that there have been no bills paid or submitted. He presented the Commission's budget of \$10,000 to the Town.

### D. Ex-Officio

P. Dagle stated the Board of Selectmen approved a STEAP Grant of \$500,000 for Cini Park upgrades which include portable bathrooms and possibly a kayak dock for people who may have difficulty getting into and out of their kayaks.

Funding in the amount of \$70,000 from STEAP and an additional \$139,000 left over from the brown field funds for the Mobil Station property was approved. There will be a Public Hearing at 7:00 PM on January 17, 2018.

### E. Niantic River Aquaculture Meeting-mediation meeting

There is a mediation meeting on February 2, 2018 at the Old Lyme Marine Fisheries. D. Landers will represent the Commission.
