#### II. MINUTES

A. Minutes of January 10, 2018

## A. Outline of Water Study Report

The document provided by Commissioner Danila regarding the catching the runoff water will be included. The study is drawing to a close. It explains the science behind the so-called wellhead protection zone, how it's calculated and the limitations on the wellhead protection area concept. Also, what improvements may be made to enhance and maintain the future quality and quantity of the water source. A detailed set of recommendations will be made.

#### B. Agribusiness Subcommittee

Commissioner Christiansen recited pertinent portions of a letter written by CT Beekeepers Association President, East Lyme Resident, and 20-year Beekeeper Stephen Dinsmore regarding the institution of a honeybee regulation. The Commission reviewed the regulation, which requires beekeepers to take a basic beekeeping course and pledge of adherence to the best management practices. Terms included in the regulation will be referenced to the Connecticut Beekeepers Association's Best Beekeeping Practices for Connecticut. Chairman Carlson will investigate the process to have the regulation added to the Town's Zoning Regulations.

Regarding East Lyme's Fair Day, Commissioner Christiansen reported on plans to host a Tractor Ride with an aquaculture theme, highlighting the Blackhawk Fishing Vessel. Plans also include a presentation dealing with oysters by Tim Londregan and Rickety Pickets Community Garden. The Friends of Samuel Smith will also be hosting a Farm Day, highlighting farming equipment.

#### D. Chairman's Report

Chairman Carlson reported that nine (9) water bars were placed at Darrell Pond two weeks ago and is hoping to begin placing 18 (eighteen) additional water bars at the Niantic Forest.
