- **5.** Ex-Officio Report. Mr. Seery reported the remediation for the Main Street project has been completed. The bricks will be used for the irrigation system. Bricks are being sold. A 4 X 8 brick is \$275 and a 8 X 8 brick is \$475. DEEP has approved moving all signs in order to see the view of the water. It is hoped the ribbon cutting ceremony will be held on Memorial Day weekend.

The budget has a 1.73% increase. The Board of Finance cut the Board of Education budget by \$200,000 and the Town Government budget by \$50,000.

Joe Bragaw, the Public Works Director, wishes to increase transfer charges to 6.5 cents per pound and \$50 to pick up five items. This increase to fees will be brought to the Board of Selectmen for approval.

A Public Hearing on the budget will be held on April 30, 2018 at the Middle School at 7 p.m. The Annual Town Meeting will be held at the High School on May 14, 2018 at 7 p.m. The budget referendum will be held on May 24, 2018 at the Community Center.

#### McCook Point Park:

- All restroom facilities have been opened for the season.
- Tent was installed today.
- 3<sup>rd</sup> Annual Niantic Bay Boardwalk 5K is scheduled for Sunday, April 22.
- Beach passes are now on sale.
- Drainage project at McCook has been completed by the Public Works crew, paving of the road between lower and upper parking lots to begin shortly.
- Two Eagle Scout projects are moving forward at the beaches one is bicycle repair station at Hole in the Wall and the second is a Library book exchange kiosk.
- Handicap accessible mats have been delivered they will be installed at the Hole in Wall and Cini Park access ramp.
- Two Wheelchairs with beach and water accessibility are also being purchased through the Rotary Club and United Cerebral Palsey of Eastern Connecticut.

#### **Boardwalk:**

• Construction of the Restroom facility at Cini Park on schedule to be completed by late May early June.

#### **Athletic Facilities:**

- Work to the cell tower at Peretz Park has started there will be no interruption to the athletic fields.
- Miracle League Field fundraising has eclipsed the \$100,000 mark upcoming events include the Niantic Bay 5K and the Niantic Rotary Gala on May 5<sup>th</sup>.
- Opening Day for Little League is scheduled for Saturday, April 28.

- Maintenance crew continues to do an outstanding job of preparing our fields. Fields officially opened on Saturday, March 31.
