Meeting Minutes

- 1) The meeting was called to order at 7:30 pm and a quorum established.
- 2) The minutes of the April 19, 2018 meeting were reviewed. The minutes were accepted on a motion by Mr. Kelly, seconded by Mr. Spakowski; motion passed on a vote of 6 to 1, Mr. Bowlen abstained.
 - The minutes of the May 17, 2018 Public Hearing were reviewed. The minutes were accepted on a motion by Mr. Spakowski, seconded by Mr. Tytla, all in favor, motion passed.
- 3) The Treasurer's report for April 2018 was presented including the financials and bank reconcilement. The Treasurer's report was accepted on a motion by Mr. Spakowski, seconded by Ms. Gelinas, all in favor, motion passed.

Mr. Kelly stated the fiscal year end is June and all permit collections have been done. He noted the Frontier phone bill account has been closed and paid in full.

- There was an incident with the boat and an abandoned mushroom anchor; the anchor will be removed soon and is now marked with an orange buoy.
- There was discussion on purchasing tow insurance for the boat.

- a) The discussion and action on the amended Aquaculture Policy statement was tabled on a motion by Mr. Kelly, seconded by Ms. Gelinas, all in favor, motion passed. Commissioners agreed a special meeting should be held with the Waterford Harbor Management Commission to discuss their concerns and suggestions and to also invite Attorney Avena.
- b) The discussion of WELSCO Aquaculture Application by Niantic Bay Shellfish Farm for Area 2 and 5 was tabled on a motion by Mr. Kelly, seconded by Mr. Tytla, all in favor, motion passed.
