
## **EAST LYME PARKS AND RECREATION COMMISSION REGULAR MEETING MINUTES APRIL 11, 2019**

The company is called Solaware and the units measure the amount of UV rays index and the amount of time your skin is at risk. Hope to get a third unit sponsored by the East Lyme Public Trust Foundation and place at the Cini Park entrance to the beach and Boardwalk.
- Work has been completed to the sidewalk at Cini Park near the car top boat launch, the sidewalk was being undermined.
