In the spring he felt we may have the same problem. Ledge Light has bricks which can be placed in standing water. There will be a meeting with DEEP to determine what is the best approach.

AMTRAK will fund a new fence from the park to the bridge.

When coming south bound on Exit 74 you need to make a left turn. Coming northbound construction will be completed in the next few weeks.

Ms. Curry asked when they redo the bridge will it be widened? Mr. Seery felt it would be.

Mr. Seery informed the Commission exit 74 will be closed for a period of time. COSTCO will have a ribbon cutting ceremony on November 14.

With everything included in the Public Safety Building, it would cost \$3 million over budget. If the jail cells were removed, the project cost would be reduced to \$2.2 million. It costs \$40,000 to use the Waterford jail cells. It was felt an elevator is needed for handicapped accessibility.

He informed the Commission we have a contractor for the Triumph Building.
