## **OLD BUSINESS:**

 Signage for Historic Houses / Property / Landmarks: John Wilson, owner of Signcraft Signs, presented mock-ups of "circa signs" as designed by Burt and Steve for consideration. Discussion ensued regarding shape, size, font, mounting holes and background. Rob moved to approve an oval sign with the font as presented by mock-up #4 on the handout sheet. Mark seconded. Approved, unanimous.

Addition discussion ensued regarding "circa sign" price and creating a vehicle for the historic properties commission to receive funds. Currently there is no vehicle. In the absense of a vehicle, John Wilson has agreed to donate \$25 per sign to the three historic properties by dividing the amount between the three.
