Bill,

Per the comments raised during the recent Public Hearing, and subsequent Drawing Set update, I offer the following:

1. Proposed sidewalk from Boston Post Road to front of the building: No issue; a sidewalk detail has already been included on Sheet C-60 of the Drawing Set.
2. Striping in front and perpendicular to the building: No issue.
3. Signage for pedestrian area; caution sign with 10 mph speed limit: It is my opinion that the small size of this site does not justify setting a speed limit sign. During busy times, even 10 mph may be an excessive rate of speed. I do encourage a "caution" sign be st and offer the example below as option to be considered:



4. Three speed bumps in front of the building: No objection, however the short distance between the speed bumps may cause for more driver distraction. One speed bump and properly placed "Caution" sign(s) should be sufficient.
