G. Goeschel referred to his memo dated, May 10, 2021 in which he listed 18 goals of the POCD. He thought the proposed text amendment was met by goal number 2. He advised the members that pending state legislation may do away with some of the signage requirements, but the town could still have signage requirements in their regulations.

The members thought the proposed language would contribute to the transparency of the town during public hearings when they are continued.

MOTION: (Williams/Davison) to move that the East Lyme Planning Commission finds the proposed text amendment referenced above CONSISTANT with the East Lyme 2020 Plan of Conservation and Development. Vote: APPROVED unanimously.

B. Application of Todd Sakowski for a text amendment to the East Lyme Zoning Regulations Section 20.28 and 25.3.3 to allow Taproom Brewery Service in CB Zones by way of a Special Permit.

G. Goeschel stated that in reviewing the 2012 POCD, he found breweries consistent with the POCD in CB zones by Special Permit. The text amendment is proposing the requirement of providing food outside be satisfied by utilizing the surrounding food establishments or food vending trucks.

G. Goeschel found that the proposed text amendment consistent with the POCD, economic development goals in the downtown area. He informed the members that the zoning official noted that the use of food vending trucks could have negative impact on the surrounding food establishments.

M. Williams thought the proposed text amendment could also be consistent with the aquaculture goals of the POCD.

G. Goeschel reminded the Commission that any restaurants with outdoor dining must get a permit every year.

MOTION: (Gordon/Davison) to move that the East Lyme Planning Commission finds the proposed text amendment CONSISTENT with the 2020 POCD. Vote: APPROVED unanimously.
