- 4) Benn reports that he is still working to get in touch with Barb Johnson-Low to clarify how she had planned to use the FY 21-22 HPC budget funds of \$2,168 for Service Contracts and Dues in Professional Organizations.
- 5) Benn reported that he had received an email from Lisa Timothy, EL Library Director relating to the ongoing effort to set-up/establish a data base of "Old Houses/Buildings" in East Lyme. She asks if he would sit on/work with the committee/ group that are working on the project. He agreed and will attend his initial meeting on 11/10.
