2b. Parks and Recreation – Compost Bathrooms

DISCUSSION: Mr. Putnam handed on information on the proposed compost bathrooms, attached hereto as Exhibit #1. He explained that they have three coming that are being funded using ARP funds; one at McCook's by the upper bathrooms, and two at Hole in the Wall next to the existing facility. Summary of the product is that it is year-round, it is solar powered and will have a fan and proport to be odor free even in high heat and humidity. The wind load is rated to 120 mph. The cost is approximately \$75,000 per unit. The town receives many inquiries into adding more public restrooms downtown and at the parks and beaches, and this product may be a particularly good solution.

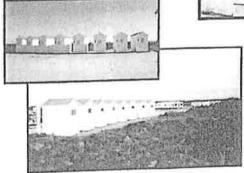


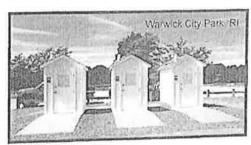




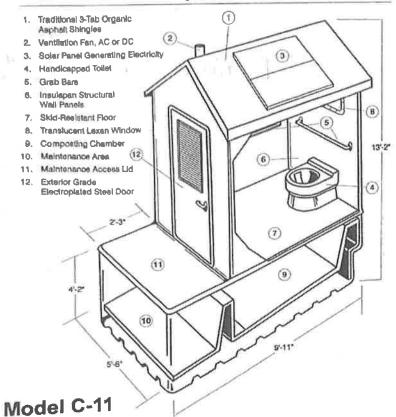




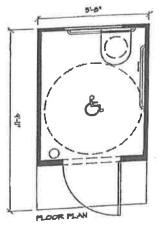


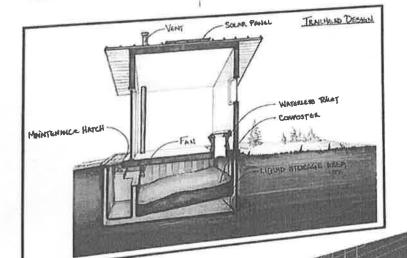


Self-Contained Recycling Composting Toilet









The Clivus Model C11 trailhead restroom is a heavy duty building with a self-contained composting waste There is no treatment system. discharge of waste or pollution, site disturbance is limited to the footprint of the building, and the ventilation fan can be operated with solar power if necessary. These units are all ADA accessible and can be placed in remote areas.
