- 1. Call to Order: C. Tomichek called the meeting to order at 6:03 PM.
- 2. **Seating of Alternates**: D. Danila motioned to seat Amy Cabaniss for vacant Salem seat, seconded by P. Harris, all in favor, motion approved.
- 3. **Review and Approval of May 2023 meeting minutes**: D. Danila motioned to approve the May 2023 meeting minutes as submitted, seconded by P. Harris, all in favor, motion passed unanimously.
- 4. **Review and Approval of June 2023 meeting minutes**: D. Danila motioned approve the May 2023 meeting minutes as amended by A. Cabaniss, seconded by P. Harris, all in favor, motion was passed unanimously.
