1. Call to Order and Pledge

Chairman Thurlow called the October 5, 2023 Regular Meeting of the East Lyme Aquifer Protection Agency to order at 7:00 p.m.

Note The Pledge of Allegiance was recited by all.

2. Attendance

Ms. Thurlow called attendance and noted Ms. Roseanne Hardy was absent.

3. Public Delegations

4. Regular Meeting

Note Ms. Thurlow noted this meeting to be a Public Hearing.

Mr. Mulholland asked to interrupt that was is a Regular Meeting, not a Public Hearing. He noted that each Member had a copy of the East Lyme Aquifer Protection Agency Map to reference, as well as a Fact Sheet, for a refresher on the Program. Additionally in each Member packet was a copy of the Renewal Application, which had been reviewed by the Board n the past, along with a New Registration. Third was a copy, of the approval from the State of Connecticut, as an FYI, as the Town does not have jurisdiction over that property.

Mr. Mulholland then explained that in reviewing the applications, some technical questions arose and because of those questions, he is asked the Board to pause on the current meeting to do some additional checking on maintenance requirements and resume the discussion of approvals at the next Aquifer Protection Agency Meeting, in the next three to four weeks. He also indicated that an additional application had come in which was not included in this current agenda.

Mr. Mulholland stated he wanted to discuss his questions with his DEEP contact. Mr. Mulholland had met with the Chairman that morning and showed her all of the literature regarding the Program as well as the documents the staff uses to track of the 16-18 businesses in Town.



Mr. Mulholland again noted there was an application, previously approved, as well as a new application and he wanted an opportunity to vet their applications to be sure nothing was over looked in ensuring our important aquifers are protected.

More Ms. Thurlow asked if the Board wanted to discuss item 3.
