The group was asked to consider whether any programs taught by or coordinated by the group would fit more under a title of "Homesteading Series" as opposed to Agriculture. Needs continued discussion.

Tom and Terri Yuhas have been invited to attend the Arts and Agriculture 4-H group at the USDA building in Norwich on March 17th. Mark Christensen also provided the contact information for a local 4-H club in East Lyme called the "Pony Tails" 4-H club.

Mark Christensen stated that local tractor vendors were having difficulty finding skilled mechanics that can work on tractors. This will be communicated to the contacts at Ledyard Vo-Ag during the future tour of the school. It was also discussed that the sub-committee could ask Ledyard Vo-Ag if they would like to have a booth to promote the Vo-Ag program at one of the events at the Samuel Smith house. Making butter could also be demonstrated and potentially

have goats to represent dairy farming in the area as opposed to dairy cows. Another option was to reach out to UCONN Dairy.

Mark Christensen stated that he may have a contact that would be willing to teach cheese making during one of the events at the Samuel Smith house.

Tom and Terri reached out to Joe Bonelli, Associate Extension Educator Emeritus UCONN Extension, who stated that they could try and answer any questions the sub-committee may have related to livestock since the UCONN Extension service has not yet hired a replacement for the prior livestock coordinator. They also communicated that UCONN had a pasture-based livestock project through Northeast SARE that could be referenced.

Discussions were held on a way to train on planting and harvesting hay for interested farmers. Needs continued discussion.
