IX. ZONING REFERRALS [Connecticut General Statue (CGS) 8-3a]

G. Goeschel informed the members that there are two zoning referrals the Zoning Commission will be discussing.

- 1. Eric Parker has asked for an amendment to section 20.26 of the Zoning Regulations to allow for a drive through window at business that do not enter/exit onto a state road. Currently the regulations stipulate that a business with a drive through window must have an exit or entrance onto a state road.
- 2. The Zoning Commission is amending section 34.2.1, architectural review, to change the word, "shall" to "may" to give the Commission more flexibility.

XII. NEW BUSINESS

A. Subdivision Regulations-Section 4: Application Submission Procedures:

G. Goeschel said that when they revised the Subdivision Regulations, they did not address the timeline for when the Commission on Natural Resources had to respond to a referral by the Planning Commission. He suggested they add language for a time limit to respond as it may be interpreted that no response is an approval.

G. Goeschel said the subdivision regulations call for an architectural review. He said very few towns in Connecticut require this review. There is a concern that the requirement may be so onerous that the developer would find it more advantageous to submit an application for an affordable development than pay for the architectural review; this would give the Commission less control over the application.

G. Goeschel suggested changes to the Subdivision Regulations to reflect these concerns.

B. By-laws:

B. Bohmbach suggested they review the section of the bylaws that discuss appointments. He said the Commission should be bi-partisan and try to get the best person with the most experience. He also suggested that another option is to replace/appoint according to party affiliation to match the party of the resigning member. The Commission decided to make no changes to the bylaws.
