## 11. Comments from Ex-Officio

- -Ms. Jett-Harris asked if the BOS had discussed the Affordable Housing Appeals Moratorium.
- -Ms. Hardy responded that there is time for discussion, and it has not happened yet.
- -Ms. Jett-Harris asked that Ms. Hardy bring the idea to the BOS that electric boxes could be painted by local artists.
- -Ms. Hardy agreed to bring the suggestion, but she thought the boxes were perhaps private property.
- -Ms. Thurlow asked if there was any discussion regarding the old police station on Main St.
- -Ms. Hardy indicated there was nothing currently, as there is contamination on the site.
- -Ms. Thurlow asked if Amtrak had any plan to replace the rusted and bent fence.
- -Mr. Mulholland recalled a distant discussion but that had been sidetracked, and he did not know the status.
- -Ms. Jett-Harris thanked Ms. Hardy for reading the literature on the Short-Term Rentals.
- -Ms. Hardy noted that the upcoming budget had proceeded from the BOS to the BOF and there was a lot of discussion, and cuts/reductions.

## 12. Zoning Board Liaison to the Planning Commission

- a. April 8, 2025- Mr. Peck gave the following report:
- -The Planning Commission is working on a 20 lot subdivision on Holmes Rd. This was continued and he wondered if they were following the Conservation Design District.
- -Mr. Mulholland stated that he thought it was an Affordable Housing application (8-30g)
- -Mr. Peck wondered why an Affordable Housing application was being presented to the Planning Commission.
- -Mr. Mulholland noted that there may be other steps that include presenting them to the Zoning Commission.
- -There is 3 lot subdivision which was approved, off of Heritage Rd.

- -There was an interesting discussion about the Zoning Referral regarding the rezoning at the north end of town. He stated that the Planning discussion did not discuss water quality or the reasons for Zoning Commission's wish for Public Hearing. He reported that the sentiment seemed to be that the Planning Commission felt the Zoning Commission only wished to slow down or stop development. He reported that the opposition to the referral was unanimous, and a large reason presented was that it would promote 8-30g housing projects because of the large lot sizes. He feels that the Planning Commission was totally uninformed of the intention from the Zoning Commission for the rezoning. He still feels that someone should discuss it with the Planning Commission because it does not seem like they are ever informed. He expressed concern that they do not seem to be informed in their decisions.

- -Ms. Thurlow asked if Mr. Peck could remember a time when someone had gone to the Planning Commission and Mr. Peck replied tat the only person who could, would be Mr. Mulholland or someone not on the Zoning Commission.
- -Mr. Mulholland noted that the departments are closely spaced, and the Planning Director could speak with him at any time. The Minutes are available online for review.
- -Mr. Foley asked if there were practical results to the Planning Commission denying a referral.
- -Mr. Mulholland noted that the statute required a 2/3 majority vote of the Zoning Commission if that were the case, which is a majority vote of a 6 person board anyway.
- -Ms. Jett-Harris asked how the valuation would work if they were 8-30g. This type of 8-30g setup of single family houses has not been done in East Lyme before.

It's that time of year again when all restaurants with outdoor dining facilities which serve alcohol must renew their permits. Section 20.25 of the Zoning Regulations requires that the Zoning Commission reapproves each Special Permit annually, provided that each restaurant has been compliant with the Outdoor Dining Regulations.

The following restaurant properties continue to be in compliance with your Regulations and I would recommend reapproval with the same conditions.

- 1.Charlie's Place
- 2. Niantic Pizza
- 3. Zavala's
- 4. Gourmet Galley
- 5. Rossa Negra
- 6. Lyme Tavern
- 7. Spice Club
- 8. Constantine's

The restaurants listed below will need to have their permits amended to reflect the installation of additional outdoor lighting in the form of strings of lights installed over the outdoor dining space. Generally, the lights have been suspended from poles surrounding the spaces. These poles provide a structural support for the lights. A review of these installations finds that the lights provide a certain ambiance to the dining experience.

I would recommend that the Board approve these permits including the additional form of lighting.
