1) AACO Ryan and Percy did quite a bit of PR this month including the mock traffic stops event and the shop with a first responder event.




2) 07/09 a bat found in a bedroom in Waterford tested POSITIVE for rabies. Resulting in the entire family receiving rabies exposure shots.
