2. STATUS REPORT

Ms. Caramanica told Commission members one of our drivers resigned. She will advertise for a new driver. Mr. Bekech suggested that Human Resources have an exit interview with anyone leaving a position in town.

She stated the new bus has arrived. It has been registered. It is at the Town garage. The drivers are very happy with it.

Mr. Bekech reported he rode with each driver. He stated each of them has wonderful personalities and are well liked. He asked riders what changes to transportation they would like to see and one individual would like more hours.

Ms. Harris asked how long is a bus trip? Ms. Caramanica replied six hours per day. Ms. Coyle added on Tuesdays some seniors come regularly for the café and then go to Stop and Shop. One day they go to Walmart. Mr. Bekech added our staff coordinates the trips very well.

b. Senior Trips. Ms. Caramanica informed the Commission trips are going very well. We received \$985.26 in commission from the Bermuda cruise.
