Hi Gary,

I apologize for the late email. I did take a preliminary look at the plans, and soil testing was performed in 2002 (it does not indicate who witnessed them from the Health Dept, though I'm guessing it was George Calkins). The test hole descriptions - nine of them - all show suitable soils for on-site subsurface sewage disposal. Percolation tests were performed recently by Bob Pfanner, which also yielded acceptable results. Based on these conditions, we would recommend the lot be considered suitable for building purposes.
