- Discussion re: ELPS Curriculum Development, Design and Implementation Presentation

- 2. <u>Discussion/action re: Superintendent's Recommendation for Use of the Education JOBS Federal Funds for ELPS</u>

Dr. Lombardo's recommendation for use of the Education JOBS (Ed Jobs) Federal Funds for the 2010-2011 school year was presented. The 2-year grant requires funding be used to save or create education jobs to ensure that students receive vital educational and related services. The remaining funding must be used by September 30, 2012.
