1 Additions to the Agenda

Mr. Schuch asked if there were any additions to the Agenda. There were none.

II Public Delegations

III Approval of Minutes- Regular Meeting Minutes of February 9, 2013

**Motion (1)

Mr. Covino moved to approve the Planning Commission Regular Meeting Minutes of February 19, 2013 as amended.

Ms. Palazzo seconded the motion.

Vote: 4-0-2. Motion passed. Ms. Bengtson and Ms. Schwartz abstained from the vote due to their absence from the Meeting.

IV Zoning Referrals (CGS 8-3a)

 Application of Theodore A. Harris, Esq., Agent for Benchmark Senior Living, to amend the East Lyme Zoning Regulations Section 9 and Section 25.5 regarding additions to assisted living facilities.

Mr. Goeschel explained that the zoning amendment which would allow the applicant to expand would be pertinent to only existing facilities, in this case Crescent Point. He also noted that the amendment would add to the town's tax base. Mr. Goeschel informed the Commission that this item will go to public hearing before the Zoning Commission on April 4, 2013.

Mr. Schuch expressed interest in learning the reasoning behind changing the zoning regulation back, when it had previously allowed for such expansion to occur. He asked Mr. Goeschel to research the history of this regulation.

Mr. Balantic expressed concern over whether such an expansion would be burdensome to the downtown and other businesses. He also noted that he too would like to review when this regulation was first changed. Mr. Balantic expressed concern over the parking impact as well.

VI OTHER BUSINESS

A New Business

a. Commission Vacancies

Mr. Schuch noted that Carolyn Nee has resigned from the Commission. He asked the Commission how they would like to proceed. Ms. Palazzo recommended Ms. Schwartz, noting that her extensive experience with the Commission would be an invaluable addition.

Ms. Palazzo moved to appoint Francine Schwartz as a Regular Member of the East Lyme Planning Commission.

Ms. Bengtson seconded the Motion.

Ms. Schwartz abstained from the vote.

Mr. Goeschel noted that the Board would now need to fill an Alternate position.

B Old Business

a. Discussion of updates to Chapter 2 and Chapter 7 Plan of Conservation and Development.

Mr. Goeschel explained that Chapter 2 is coming along slowly, that it is half way done, and that the map would require more time. He said that Chapter 7 was included in the meeting packet and asked that the Commission peruse it so that it could be revised if needed.

Mr. Schuch stated that he is waiting to hear back from Ms. Lange.

Route 11 Greenway Authority Commission
