**November 5, 2009**

**McCook Point Park:**

- Upper bathrooms have been winterized the lower bathrooms and the Hole in the Wall restrooms will be winterized later this month.
- Brush work along the point from Hole in the Wall to the Main Beach has been cleared by prisoners from Gates they have also put together the new picnic tables for McCook, cleared brush and did some painting at Vets, they have been a tremendous help.
- Opening ceremonies for the Hole in the Wall project were conducted on October 15 in a steady rain. Approximately 40 people attended.

**Athletic Fields:**

- Pee Wee Football and Little have completed there seasons. Soccer Club and Babe Ruth Baseball will finish this weekend. Fields have held up well to date.
- We will be concentrating on renovations to Veterans Memorial Park this fall. Irrigation project to complete the baseball field started this week, new infield material for the Softball field will be installed next week and the fencing replacement will take place before the first of the year.

**Liberty Green:**

- Main Street renovations have started and they will be moving to the north or Liberty Green side shortly. Addition to the Town Green will be the installation of two lights along the new paver sidewalk. The town would like the commission's approval of the two lights.

**Miscellaneous:**

- Preliminary Budget is due to the Finance Office in early December, I will have a draft for you at our next meeting.
