

Director's Report June 11, 2015

McCook Point Park:

- As of June 11th we have issued 2,500 vehicle stickers. Gate Attendants started Memorial Day weekend. We will go with full staff on Friday, June 19th.
- Swim buoys and the raft have been installed.
- Touch-A-Truck was a huge success again this year, it was held on Saturday, May 16th.
- "Bright" Concert was held on Sunday, May 30, everything ran smoothly.
- Sign Kiosk's at the Pavilion and Tent are complete this is part of an Eagle Scout Project.
- Line striping for Cini Park was completed in late May, the Hole in Wall Parking lot will be done after High School Graduation.
- Band Shell Committee recently met and are recommending a location for the future structure. The committee will meet again in the fall to start finalizing plans for the design and cost and present to the Parks and Recreation Commission.
- Hiring of new staff and orientation's have been completed.

Cini Park/Boardwalk/Beach

- 4 additional porta-potties have been delivered we presently have six located there and they are cleaned twice a week.
- Conex box will be delivered next week.
- For the last two weekends we have sold day passes at all three beach locations, this has been well received.
- We are moving the Lifeguarded swim area approximately 60 yards closer to the fishing jetty.

Athletic Facilities:

- East Lyme Youth Lacrosse is hosting an end of the season jamboree this weekend. They have done a good coordinating logistics with the department, the Police Department and local businesses. All 5 fields are being used, they had a mini jamboree last Sunday for U9 age groups and it ran smoothly.
- Work has started on the new pavilion at Peretz Park, footings have been poured and the flooring will be poured hopefully tomorrow.
- War at the Shore continues to host Baseball tournaments almost every other weekend, things have run smoothly.
- Deep tine aeration was completed today on Keser, Berardo, Firehouse and Middle
 School Soccer Fields. Berardo was top dressed today and will be slice seeded on Friday.
- PeeWee Football Field has been top dressed and slice seeded.
- We will be closing down the Berardo Field starting Monday, June 15 and keeping play off until mid-August.
